a) The Nuclear Option

a) Instructions to the Board of Directors if the ECS ceases to exist.

(1) Each region of the Empire will pick up to three 501(c)3 non-profit organization that the region funds will be donated, in the event that the ECS ceases to exist.

The Empire is at an all-time membership low, we need to prepared for its possible death.

b) **Baron Sir Coronata MacMurin is no longer a member of the ECS. The Corporate Bylaws includes the following:**

ARTICLE VI

Section 1. Dissolution. In the event that the Shareholders move to dissolve the organization, either by majority vote or written consent documents as defined in Arizona's Business Corporation Act, all physical assets of the organization are to be sold at fair market value or through auction, with all proceeds to be deposited in the main corporate bank account. Any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501(c)(3) of the 1986 Internal Revenue Code (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the E.C.S.

**Decision:** Article VI will be amended as noted below in italics:

Section 1. Dissolution. In the event that the Shareholders move to dissolve the organization, either by majority vote or written consent documents as defined in Arizona's Business Corporation Act, all physical assets of the organization are to be sold at fair market value or through auction, with all proceeds to be deposited in the main corporate bank account. Any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501(c)(3) of the 1986 Internal Revenue Code (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the E.C.S. *as recommended by the regions of the E.C.S.*

a) Changes to the LI: Change Sec. IV.C.2.a (responsibilities of the Kingdom/Territorial Minister of Combat) from:

a. Be responsible for issuing Fighter Authorization Cards;

To:

a. Be responsible for qualifying (and requalifying where necessary) fighters;

Add Sec. IV.D.1.e (Responsibilities of the Minister of the Rolls):

a. The Imperial officer shall issue Membership Numbers and notify the Kingdom officers. Kingdom officers are will use numbers provided by imperial officer.

***Rationale:*** *This brings the LI into alignment with current practices within the ECS.*

- c) Changes to the LI: Add Sec. IV.I.3 (Ministry of the Web):  
Official Facebook groups and Kingdom message boards are considered official publication with regards to event and document publication requirements.  
**Rationale:** *This brings the LI into alignment with current practices within the ECS.*

**Secretary is instructed to make the change and include under Rights of Membership:** *Access to all Facebook Groups and Boards appropriate to the individual's rank and title within the E.C.S.*
- d) Changes to the LI: Add Sec IV.I.1.c (Responsibilities of the Imperial Webminister):  
The Imperial Webminister must have full Administrator capabilities on all official Facebook groups and message boards at all territorial levels.  
**Rationale:** *This brings the LI into alignment with current practices within the ECS.*

**Secretary is instructed to make the change and include:** *Except Peerage boards. All Peerage members are to be granted moderator status to their Peerage boards.*
- e) Changes to the LI: Change Sec. VI.B.1.b (definition of a War) from  
An Official Event fielding at least ten (10) Combatants and attended by 70% or more of the paid members in a Subject Territory. At least ten of the Participants must be paid members.  
To:  
An Official Event attended by 70% or more of the paid members in a Subject Territory. At least ten of the Participants must be paid members.  
**Passed Unanimously**
- f) Also change Sec. VI.I.2.b.ii (Definition of a War) from  
70% of the paid members, but no less than ten (10) paid members of a Subject Territory; or,  
To:  
70% of the paid members of a Subject Territory; or,  
**Rationale:** *With the population numbers of territories changed, it may be difficult for smaller territories to field 10 combatants. This still ties the War event to something attended by the majority of the territory.*

- g) Changes to the LI: From Sec VI.J.2.a.i.2 (Elevation to Knight Civil) and Sec VI.J.3.a.iii (Elevation to Knight Premier), strike the phrase "worth 35 to 50 points."  
**Rationale:** *It is stated elsewhere in the LI that Ministry Projects do not earn points themselves, but rather the Project is awarded points normally. This brings the requirements for Knight Civil and Knight Premier into accordance with the rest of the LI.*

- i) A written apology from the 2019 Board of Directors to the Empire of Chivalry and Steel for infringing and threatening the rights of paid, lifetime members. The public attempt to wrongfully take away their membership status is not recognized by the Imperium and these slighted members deserve to be shown by the Imperium that their respect and trust is desired in order to continue fostering the goals and values of the ECS.

**Rationale:** The reasoning for this apology is two-fold.

1. Memberships and Dues fall under the purview of the Imperial Estates.

- a) Imperial Policy V within LI v. 18 states that the IE have say over what can be done with Lifetime membership monies. The IE may meet to reimburse Lifetime membership monies. I would even argue that the spirit of the policy would allow for the IE to reinstate Lifetime memberships.
- b) Imperial Policy V, previously policy 21 in recent versions of the LI, was put in place by the IE. I am unable to find records of the meeting, but this policy was not in place until 2006. LI v. 13 which was published in 2005 does not have this policy. So this was new, put in place by the IE.
- c) It was by a vote of the IE that raised Membership fees from \$25 to \$30. I am unable to find the records personally, but I was in attendance of that IE meeting. This would have been around 2003 – 2005. I remember it well because there was a lot of debate over the fact that the BoD at the time were not disclosing any money numbers that justified the increase. Regardless, it was an IE motion that raised the Membership Fees. So, the precedent has been set in multiple ways that Membership Dues fall under the purview of the IE, not solely by the BoD.
- d) Besides the above examples, the following list of LI sections contain laws that have been put in place by the IE, thus solidifying the fact precedent is in place that places Membership Dues and Fees in the hands of the IE, and as such, cannot be changed solely by the BoD.

II, A (Membership Dues)

II, C (Membership Rights)

II, F (Expenditures, including raising Membership Dues by 2/3rds of Imperial Votes)

II, G (Debts and Fees)

2. If the BoD had gone through the proper channels to deal with the issue requiring them looking at removing the Lifetime Membership Option, no apology would be needed. Instead of properly announcing and documenting the proposal and decision, it was blatantly published on ECS pages without any warning or reasoning. Yes, the BoD is claiming that the “Discussion Item” from the IE meeting held on June 15, 2019 is the documentation for this. However, that was

just a discussion item. It held no vote or any further action. The BoD states that if anyone had issue with this item, they had plenty of opportunity to object. However, again, this was a **Discussion** item. There was no reason to object to a discussion that was had. Discussions do not lead to actionable items unless they are brought forward as an official item to be voted upon.

Note: The apology stated at the IE meeting and documented in the Minutes of the meeting shall meet the apology requirements of this item.

- j) Change LI II, A, 2 from “\$30.00 per annum” to “\$35.00 per annum.”

This including changing all mention of a \$30 yearly membership due to \$35.

Leave II, A, 3 “Participating Family” as-is.

**Rationale:** Membership levels are low. Just like what was done in 2003 – 2005, we need to raise yearly membership dues in order to continue paying for our existing insurance premiums. However, let’s leave the family discount in place as-is as to not drastically change the amount our existing families pay. We do not want to drive them away with too steep of raised fees.

**Rationale:** The full removal of the lifetime membership to help with keeping the Empire of Chivalry and Steel, Inc solvent. Per the current leadership this option is not being used by new members, so it makes since to remove the optional all together.

That all members that currently have paid the Empire of Chivalry and Steel, Inc have their lifetime membership reinstate and grandfather for the following:

- life of the organization
- or life of the member
- or the member submits in writing or email that the fully resign from the Empire of Chivalry and Steel, Inc
- Or full banishment from the Empire of Chivalry and Steel, Inc as outlined herein the current L.I.

**Rationale:** The reinstatement and grandfathering of the member who in good faith purchased the lifetime membership as was presented to the membership when was

offered by the Empire of Chivalry and Steel Inc. and was purchased in the good faith it was offered.

**Note from the secretary:** *No vote was taken on this item. Due to a technical error, there is no recording of the meeting. As I recall, this was withdrawn as unnecessary after Michael Gilmore's announcement on November 6, 2019 as follows:*

Greetings unto the Empire,

Due to concerns raised by a few club members, the Board decided to revisit the BoD decision of annulling or prorating current Lifetime Memberships.

The Board could not come to a unanimous decision, so we, the Board of Directors for the Empire of Chivalry and Steel, inc. have decided to allow the current Lifetime Memberships to stand until we can come to reasonable accommodations so all concerns can be addressed.

The voting members were President, Vice-President, Secretary, and Treasurer. The vote was split, but the President didn't feel that using his additional tie-breaking vote was in the best interests of the club.

This decision and the original decision were made to protect the mundane interests of the corporation and thus fell within the purview of the Corporate Bylaws of the Empire of Chivalry and Steel, inc. which supersedes the Imperial Bylaws or Imperial Estates. The Board's authority to take such actions fall under Article II, Sec. 11. Action Without A Meeting.

Lifetime members who bounce a check will have their membership privileges revoked as of March 30 (the renewal date) if they have unpaid fees dues to the club. Membership privileges are fully restored upon payment of the debt.

**Rationale:** This is just housekeeping to put back the clause regarding bounced checks by a lifetime member of the Empire.
